

## **Plummer Family Sports Park – General Rules**

Plummer Family Sports Park is a publicly-owned complex and reserves the right to remove or ban any individual or team that violates the rules below.

- Unsportsmanlike behavior, vulgar language, physical or verbal abuse towards players, coaches, fans, umpires, or park officials will not be tolerated.
- Smoking, vaping, chew, or any use of tobacco products is strictly prohibited on the property.
- All animals must be on a leash and must be cleaned up after.
- Small pop-up canopies shall only be allowed in areas approved by the Parks and Recreation Department. No staking or tying off on park structures or amenities allowed.
- Noisemakers are not allowed on park property (e.g. cowbells, horns, sirens, whistles, etc.).
- Paint, "silly string" or equivalent, markers, water balloons, confetti or other littering items are prohibited.
- No alcohol is permitted to be brought onto the property without written consent of the City of Edwardsville and only by vendors registered with the Parks and Recreation Department.
- No climbing on fencing, dugouts, buildings, walls or other structures within the park.
- For the safety of participants and spectators, glass containers are prohibited.
- Guns, knives, slingshots, or weapons of any kind are prohibited.
- The use of drones or remote-controlled vehicles is prohibited without prior written consent form the Parks and Recreation Department.
- Grilling or cooking shall only be allowed in park provided grills and designated areas.
- Open flame heaters are prohibited.

## **Plummer Family Sports Park – Sports Fields Rules**

Plummer Family Sports Park is a publicly-owned complex and reserves the right to remove or ban any individual or team that violates the rules below.

- Unsportsmanlike behavior, vulgar language, physical or verbal abuse towards players, coaches, fans, umpires, or park officials will not be tolerated.
- Food, candy, gum, or seeds/shelled snacks are not allowed in field areas, including dugouts.
  - A \$250 clean-up fee will be charged to organizations if violations occur.
- Steel spikes are prohibited on all fields.
- No animals allowed within sports field areas, with the exception of service animals.
- No chairs of any kind are permitted inside sports field areas (turf). Spectator chairs must be positioned on concrete sidewalks or along grass areas.
- Small pop-up canopies shall only be allowed in areas approved by the Parks and Recreation Department. No staking or tying off on park structures or amenities allowed.
- Skateboards, scooters, or bicycles are prohibited within the sports field areas.
- No climbing on fencing, dugouts, buildings, walls or other structures within the park.
- Batting practice is allowed in the batting cages only.
